

Terms of Use

The 'Terms of Use' pertain to the Fuel BI application found inside MyGeotab and all affiliated websites connected to www.FleetHoster.com by Fleet Hoster, its subsidiaries, and affiliates, which include Fleet Hoster's global websites Fleet Hoster LLC ("FH") and its licensors own the rights to the Application and Site. By accessing the Application/Site, you are acknowledging your agreement to abide by these Terms of Use; if you disagree, refrain from using the Application/Site.

FH reserves the right to modify, amend, add, or remove any part of these Terms of Use at its discretion. It is your responsibility to regularly review these terms for updates. Your continued use of the Application/Site following any alterations indicates your acceptance and agreement to the changes.
